IX. Public Comment Period

- a. The sole purpose of this meeting is the final ranking of the most qualified teams with an initial concept. Accordingly, there will be one Public Comment Period. All public comment must be made during the Public Comment Period. Anyone interested in providing public comment must fill out a card and such individual shall have one opportunity, up to three (3) minutes, to provide public comment. A card can be obtained from the clerk and an individual may only submit one (1) card. Pooling of time is not permitted. Since this is a televised meeting, copyright law and other federal laws and regulations must be observed, therefore any use of the overhead projector and other electronic media during this Public Comment Period must be in accordance with the City Clerk's and City TV Station's policies. All public comment must be related to the final ranking.
- b. The Chair will open the Public Comment Period and the clerk will call individuals who wish to provide public comment in the order that the cards were received. If your name is called and you are not present you will lose your opportunity to provide public comment. Once the last card is called no additional cards will be accepted. The Chair will close the Public Comment Period immediately following the comment of the last speaker who has submitted a card in a timely manner as provided above.
- **c.** Once the Chair has closed the Public Comment Period there will be no additional opportunity for the public to provide comment during this meeting. After the Public Comment Period has been closed, the Selection Committee will commence with deliberations and determination of the final ranking.
